Fire Control and Rescue District, it is up to voters to decide whether

or not that solution will be implemented.

There is an air of certainty that the proposal will be approved, but some concerns and questions may still remain for voters as to whether or not the individual price tag will be worth the improvements promised. New equipment has already been acquired, and more have been purchased with delivery dates in the near future. So how exactly will things change, and what will it cost individual home owners, and what formula exactly is being used to determine that cost?

n November 8, 2022, there will be a referendum on the General Election ballot for Sumter County

residents living within and near The Villages

to decide if The Villages Independent Fire Control & Rescue District will provide Fire and EMS services pursuant to Chapter 191, Florida Statutes.

This implements a series of community decisions developed and made over the last several months involving a community consensus arrived amongst your elected officials from the community development districts, the Sumter County Commission and administration, and many opinion leaders in our community. The Legislature and Governor have agreed to allow this evolution in service. The next step is for the electors to review—YOU DECIDE!

As a Sumter County resident living within and near The Villages, your decision will be voiced by voting on the November 8th referendum. To ensure that every eligible voter has all of the necessary information and can read about what this means for them, we have created a page on the District website that has answers to frequently asked questions we've received. In addition, we have put together two educational videos to provide additional clarification. NORTH AREA

n August 17, I attended the Open House held by The Villages Public Safety Department at Station 40 on Parr Drive. I sent an email to all the North

Area Neighborhood Representatives to tell them about what I learned. That email follows:



I just got home from attending the first Villages Public Safety Open House at Station 40 on Parr Drive. It was very impressive. With my daughter, who is an experienced paramedic, we toured the entire facility and spent most of our time study-

ing the new Ford F-450 ambulance. This is a very highend truck, with power-assisted gurney lift, air lift box for leveling on sloped drives, pumps and ventilators and room for large numbers of EMT/Paramedics in acute cases.

We were able to speak with Deputy Chief James Goodworth (shown left with me) and Chief Edmund Cain to learn a lot about the impact of the proposed Special Fire District. Here are some key takeaways:

- Both Chief Cain and Deputy Chief Goodworth "cut their teeth" in emergency medical service, merging EMS with firefighting as their careers progressed. As they add full EMS service to The Villages Public Safety Department, we are fortunate to have management that understands the duties and difficulties of emergency medical intervention and transport.
- Currently, under the existing contract with AMR, there are nine ambulances serving all of Sumter County, including The Villages. The Villages Public Safety Department has received three units as of today, with three more due this month, and three to six more in September. If any are delayed, the manufacturer will provide "loaners" to bring the total to twelve. Sumter will continue to provide a fleet to serve the rest of the county, so the result will be a lot more ambulance coverage for the same total area.
- One of the new ambulances will be based at the existing stand-alone paramedic station at Springdale postal station, replacing the old first-response truck.
 For District 4 residents, we will now have both a Villages and a Marion County ambulance based within mere blocks.
- As reported in The Daily Sun, a new cooperative agreement has been signed with Marion County, so the added Villages EMS capability should have little impact on our taxes or fees. It should improve the service in that the closest truck will be able to serve us AND transport us to the appropriate emergency room, as needed.

- Another of the ambulances will be based at the Paradise fire station. For folks in the historic section of The Villages, this means that service should come from the nearer of The Villages EMS or a Lake County ambulance.
- Again, as reported in The Daily Sun, there is a new agreement with Lake County, so the added EMS capability, by itself, should not have much effect on taxes or fees.
- Initially, for the next year, a cooperative agreement with Sumter County will be in place, and as a result, for the upcoming year the added Villages EMS capability should not significantly affect taxes or fees. In all three counties, the costs will of course be affected by inflation, but NOT by the new services.

It behooves us to attend The VHA General Meeting on September 14 (which is open to ALL Villages residents) to learn all we can about the long-term effect on taxes for Sumter County and fees for Districts 2 and 3 in the North Area. If I lived in Sumter County, I would vote "Yes" for the independent Villages Fire/Rescue District, and I believe the upcoming Open Houses and The VHA meetings will help make that clearer for everybody.

There will be another VPSD Open House on September 20 at Station 47, 4856 S. Morse Boulevard. In addition, The VHA will hold an open meeting on October 24 at Ezell Recreation Center featuring Chief Edmund Cain. If you live in Sumter County, I urge you to inform yourself so you can vote wisely.

To help keep us safe, we have Law Enforcement Agencies like the Sheriffs and Police Departments, locks, dogs, neighbors, security systems, camera systems, lighting systems, the 2nd Amendment, 911, and more ex-military, and more ex-law enforcement, than most communities in the country, outside of a military base. In addition, we have Community Watch. I appreciate all of the above.

The Villages Community Watch is a wonderful organization. They are on duty 24 hours a day, 365 days per year. Community Watch has Patrols, Gate Attendants, Gate Operations, and Dispatch/Communications. Community Watch offers a House Check program, a Resident Out-of-Area Program, and an Adult Watch Program. To learn more about these programs call them at 352-753-0550.

To learn more about our local government, I have taken, and recommend, The Villages Orientation, and The Villages Resident Academy. You can sign up for Orientation by

hy do governments have reserves?
Because they don't go out of business. There is a difference between government accounting and commercial ac-

counting. That difference is that government keeps going on. This is where people snicker and say government is dumb and so forth. It got you this far, right? So, something is working. In The Villages you have pools, landscaping, recreation centers, and entertainment, so life isn't all that bad.

Commercial businesses come and go, they buy assets and depreciate them over time. If they decide to go out of business, or change drastically in some way, they can sell off or otherwise dispose of assets.

A government cannot do that – its assets deliver services to the residents (think of a fire truck or a highway) and they cannot simply sell it or let it fall apart. And, a government doesn't go out of business.

The assets of a government have to be maintained, at all times, and in good working order. If a water line keeps breaking or a bridge becomes unsafe the powers that be usually hear about it quickly. That is where reserves come in. That depreciation that exists in commercial accounting, and is just a book figure, should be an actual cash balance in fund (governmental) accounting.

If an asset is at the end of its useful life, either as a factor of time or from unexpected failure, there should be cash on hand to replace it if the governing board had the foresight to plan properly. By the way, if a government suddenly needs a very large tax hike because they can't pay for the failure of an asset you know that there may have been some bad planning along the way.

In summary, governments have reserves because they don't go out of business and have to always be sure that they can keep things running smoothly.

I would add a clarification here about Sumter County. The 25% tax hike of a few years ago was not because of an asset failure. I read the financial reports and it seems that most of the spending was an increase for new budget items, an expansion of services. I wasn't all that disturbed by it; taxes were very low to start so 25% of next to nothing is very little.

Moving on, The VHA continues to have monthly Bingo with cash prizes. In September we are at La Hacienda Recreation Center. Admission is \$10 and that gets you two game boards, if you show your VHA membership card you get an extra board free. Additional boards, 50/50 tickets, and last game \$100 prize blotter sheets are also available for sale.

I ran into one of our newest social groups "The DeLunatics" from one of

our new Villages here, the Village of DeLuna. They were having a great social meet and greet at Everglades Recreation. You could tell that many new friendships were being developed. For some new residents, driving in the many roundabouts may be a new experience. There is a great informational brochure on the district government website,

www.districtgov.org, that explains how to navigate roundabouts. You can find it under the "risk management" department. Even if you're not new to the community, consider reviewing the information to refamiliarize yourself with the best practices and navigation markings used in the roundabouts.

Another question that sometimes arises is "which side of the multi model path should pedestrians be on?". Florida Statute 316.130.4 states: 'Where sidewalks are not provided, any pedestrian walking along and upon a highway shall, when practicable, walk only on the shoulder on the left side of the roadway in relation to the pedestrian's direction of travel, facing traffic which may approach from the opposite direction'. Sounds like pedestrians should walk on the left side of multimodal paths facing traffic

At our neighborhood representative meeting, it was agreed that we will continue with monthly program meetings here in the Far South for 2023. Our August monthly program was well attended with many questions from the audience for Mr. Mike Harris, the Assistant Director for Landscape, Water Resources, Roads, and Infrastructure. Mike provided a wealth of information, and we really appreciate him spending an evening with us. Our September program will be all about Golfing In The Villages (September 26th, at 7:00 p.m. at Ezell Recreation Center).

We have a very important decision to make on November 8th regarding whether to establish an independent fire district. There is some significant misinformation being spread about costs associated with this decision. I urge you to seek the facts from those who have the facts. The Villages Public Safety Department will have an open house on September 20th at Station 47. Consider visiting and obtaining information directly from those who are educated and fully informed. The VHA is also sponsoring

two informational sessions concerning this decision. Our September 17th General Membership Meeting will be focused on this topic as well as the October 24th Far South monthly program meeting. ave you ever wondered how your membership dollars are used? The Villages Homeowners Advocates assembled a team of willing and capable residents to form The VHA Foundation Committee with a mission to distribute philanthropic support to organizations and programs that benefit residents of The Villages, and empower our community

through knowledge, commitment and caring.

The VHA Foundation Committee is chaired by Peggy Fiore of the Village Santiago. She serves along with Carol Duggan of the Village Santiago, and Gary Frigiola of the Village of Hawkins. The VHA Executive Vice President, Peter Russell, acts as The VHA Board liaison and non-voting member.

The VHA Foundation Committee has made several gifts within their first few months. A grant of \$500 was presented on June 30th to RaeAnn Bethel, the Village of Bonita, and Fran Inco, of the Village of Pennaecamp for the Girl Scouts Alumnae Silver Trefoil Group of The Villages to purchase pajamas for their annual Pajama and Book Drive. The program provides over 600 homeless children in Marion, Sumter and Lake counties with a pair of pajamas and a book. You may have seen their collection boxes in the Recreation Centers of The Villages during the holidays. "Your donation will truly help those most vulnerable in our community," wrote RaeAnn Bethel in an acknowledgement note to the Committee.

More recently, a grant of \$1,000 was presented

to Andy Hendricks, a resident of the Village of Poinciana, to help Shared Harvest Community Garden purchase pressure-treated lumber to replace the frames on their 20+ year-old raised beds used to grow seedlings. A 100% volunteer-driven project, Shared Harvest Community Garden grows crops year-round to provide produce to local food programs such as the Wildwood Soup Kitchen, Fruitland Park, and the parishes of St. Timothy, Hope Lutheran, New Covenant United Methodist, and St. Theresa, to name just a few. Each year the gardens distribute about 25,000 pounds of produce. "That certainly helps keep The Villages and our surrounding neighbors 'America's Healthiest Hometown," commented Peter Russell.

The VHA is committed to five broad areas of need: Evaluation and support services to help The Villages' residents to remain in their homes as long as possible; transportation services; home-delivered meals; caregiver resources; dementia programs and services. If you are aware of worthy organizations in our community whose mission aligns with these commitments, they may be considered for a grant. awn service companies provide services that eliminate time-consuming lawn maintenance activities such as mowing, edging, water-

ing, and fertilizing, as well as the pruning and maintenance of trees and shrubs. Some companies require expensive and long-term lawn care contracts, so you should take the time to investigate and find a reliable company with a good reputation.

ASK YOUR NEIGHBORS. Talk with others in your neighborhood that have used lawn care services. Find out which companies have done a good job and why.

CHECK ON LICENSING AND COMPLAINT RECORDS. Before contracting with any lawn service, call any Seniors vs. Crime office and ask how many complaints have been filed against the company you have in mind. If the company does

chemical applications, other than fertilizer, verify that the company has a pest control license issued by the Department of Agriculture and Consumer Services by calling 1-800-HELP-FLA for any licensure and complaint history on any pest control business licensee. Also, check with your local BBB to see if any complaints have been filed against the company. Verify that the company is insured to cover any accidents that might occur while work is being performed.

READ YOUR CONTRACT CAREFULLY. See if there are any extra charges for special services, such as fertilizing, disease control, or re-sodding. The contract should specifically state the term of the service contract, frequency of the services performed, and the costs of contract renewal. The contract should also state whether or *SENIORS VS. ALERT SUMTER AND CRIMELINE



Today, getting information from reliable sources is more important than ever before. For that reason, we utilize multiple methods to communicate important public safety information such as AlertSumter, our Sheriff's Office app, social media, and local media outlets.

Alert Sumter is a county-owned software application in which citizens can register to receive phone calls, texts, and emails. The Sheriff's Office uses this application as a reverse 9-1-1 to alert the public to emergency situations along with other important public safety notifications.

In 2018, the Sheriff's Office launched an app to offer additional communications options to our citizens. The app features sex offender information, our exclusive scam blog where citizens can share and view scam information, our 10 Most Wanted, news alerts, and more. When we put information out on Alert Sumter we also place the same information on our app and social media.

While we have multiple avenues to share information with you, we do want to encourage everyone to report information directly to us, or through the Crimeline tip line. Unfortunately, when



the public posts on social media about crimes, suspicious behavior, and other important criminal information, rather than reporting to the Sheriff's Office and making us aware, a crime may very well go unsolved. We are asking that you "CALL IN BEFORE YOU LOG IN", report directly to the Sheriff's Office rather than just posting online what could be important crime information.

not the services provided are guaranteed.

MAKE SURE THAT YOU ARE RECEIVING CUSTOMIZED SERVICE. Each lawn is different. Your lawn does not necessarily need the same treatment as your neighbor's. Ask to see evidence of specific and real problems before you agree to any treatment.

USE CARE IN THE AUTHORIZATION OF CHEMICAL TREATMENTS. If pesticides are going to be used on your lawn, find out what specific lawn problems are being addressed and inquire about the availability of less harmful chemical compounds or alternatives to chemical treatment. You are entitled to a copy of the pesticide label if you request it. If pesticides are used, find out what you need to do during the chemical treatment and for how long. How long should you stay off treated areas? What about your pet's safety? Florida law requires the posting of a sign at the time of application to notify persons that the yard has recently been treated.

FILE A COMPLAINT. You may file a complaint against a lawn service provider with Seniors vs. Crime at www.seniorsvscrime.com. Additionally, you may file a complaint with the Department of Agriculture and Consumers Services online at www.800helpfla.com
